  use of the budget reduces barriers and improves equality for all. There are no negative impacts

- In general terms cultural services is a positive resource for promoting equalities. In each instance of policy development under the new strategy, specific consultation will be undertaken.

#### 11 Active Aberdeenshire

- · No negative impacts have been identified.
- Service focuses on young people, and endeavours to encourage higher usage by the statutory groups with regular evaluations of how this can be improved.
- As the service aims to develop the capacity to deliver services in the community, it is in a position where it can set up a programme and then move on to a new one which can enhance services for protected groups as well as the wider community.
- There are some aspects of the service that are in their infancy (the leisure lend service). Whilst they may not meet the needs of protected groups at the minute it is expected that the service will improve as it is developed.

#### 12 Sports & Leisure Management - Client

- Negative impacts have been identified, these can be mitigated.
- Any changes in programming have the potential to benefit one group at the expense of another. However these can be mitigated by ensuring that the overall programming offers reasonable alternative opportunities or times to groups that may be disadvantaged.
- Ideally the service will deliver a sufficiently broad portfolio of services that evidences a willingness to meet a wide range of needs over a time period (typically a week).
- There is recognition that in some swimming pools there may be a need to increase swimming lesson provision to meet demand, which may impact on other user groups. This impact may not be mitigated in the short term but may be mitigated in the long term by the development of new pools with increased provision capacity. (Ellon, Banchory, Alford and possibly Inverurie).

#### 13 School Catering

- · No negative impacts have been identified.
- Provision of nutritionally balanced meals to pupils promotes health and well being and provides value for money for parents.

#### **Social Work**

#### 14 General Fieldwork

- No negative impacts have been identified.
- The budget funds the salaries and operational day to day running costs for the Directorate.

#### 15 Business Services

- No negative impacts have been identified.
- The activity provides the financial resources to support the delivery of the Business Services Team Plan.

#### 16 Out of Hours Service

- No negative impacts have been identified.
- This budget line supports the delivery of the Out Of Hours Emergency Service which ensures that an emergency social work service is available to members of the community in situations that cannot wait until the social work offices reopen. This service is provided irrespective of the presence or absence of any of the protected characteristics.

## 17 Criminal Justice Services (Grant Funded Services, Prison Social Work, Community Justice Authority)

- No negative impacts have been identified.
- The assessment is that the impacts are neutral. This is because there is no major change to Criminal Justice.

## 18 Adult Services (Community Care, Day Care, Residential Care, Employment Development, Mental Health, Substance Misuse)

- No negative impacts have been identified.
- The assessment is that the impacts are neutral. This is because there is no major change to the Adult Services Budget.

# 19 Older People & Physical Disabilities (Care Management, Change Fund, Day Care, Home Care, Residential Care, Very Sheltered Housing, Community Occupational Therapy, Joint Occupational Therapy Service, Commissioning, Adult Support, Sensory Impairment)

- No negative impacts have been identified.
- The activity provides the financial resources to support the delivery of care for older people and people with a disability. The assessment takes account of the relative importance of care to those with protected characteristic groupings.

#### Housing

#### 20 Affordable Housing

- Negative impacts have been identified, these can be mitigated.
- The Housing Service will continue to maximise funding streams to optimise the delivery of
  affordable housing; this may include preparing bids to Scottish Government for further funding,
  using alternative funding models where appropriate and providing other affordable housing
  tenures to address housing need.
- The Housing Service will continue to identify suitable land for the development of affordable housing through discussions with stakeholders, both internal and external, for example Property Estate, Planning, other public bodies, private developers and landowners.

- No negative impacts have been identified. However, this EIA is for the current budget and once
  decisions are made about the budget for 2016-17 and beyond it will be necessary to look at
  these afresh. Any decision to reduce the Chief Executive budget would be likely to have some

  Aberdeenshire.

#### **Environmental Services**

#### **25 Consumer Protection**

- No negative impacts have been identified.
- The service is open and accessible to all. Some additional help would be provided to those not able to progress their complaints by themselves due to some vulnerability. Some legislation has a greater impact on some groups than others for example legislation controlling sales of some products to those that have acquired a certain age.

#### 26 Animal Welfare

- No negative impacts have been identified.
- The Service is primarily concerned with maintaining the health and welfare of livestock, and enforcement of animal health legislation and does not have a negative impact on any of the protected groups

#### 27 Public Analyst

- No negative impacts have been identified.
- This service focuses on analyses of samples. The outcome of the analyses is passed to the relevant service: Equality Impacts Assessments have been completed in respect of those services and any impacts identified in those assessments.

#### 28 Environmental Health (Administration and Environmental Health Grants)

- No negative impacts have been identified.
- The services provided are based on legislative requirements with all people treated in the same way.

#### 29 Waste Management, Refuse Collection, Waste Disposal and Street Cleansing

- Negative impacts have been identified, these can be mitigated.
- Assisted Collections available for those who cannot manage their bin(s) (including Food waste bins) helps disabled people, less able people, elderly, pregnancy / maternity.
- Production of Translated Guides to advise on new Service to all householders helps all races / language abilities.
- Language Line available 'on the doorstep' helps all races.
- Mini glass recycling points will be installed in as many locations as possible to decrease the distance that people have to travel to recycle their glass.
- Provide assistance where needed at Household Waste Recycling Centres.
- Adaptations may be made to Street Cleansing frequencies / areas to suit local needs / needs of protected groups / persons in that area following request. These may be permanent, temporary or seasonal.

## 30 Planning (Planning Administration, Building Standards, Development Management, Sustainability, Information & Research, Policy & Environment and Ranger Service)

- No negative impacts have been identified.
- Overall there is an increase in budget figures to cover staff salaries/wages and superannuation. This ensures that they can perform their functions in ways that meet equality duties.

#### 31 Building Services (Building Cleaning, Public Conveniences)

- · Negative impacts have been identified, these can be mitigated
- By providing public toilets in settlements throughout Aberdeenshire we ensure that these facilities are available to people of both sexes and, where reasonably practicable, to the disabled as well as the able-bodied.

## Office Accommodation (Woodhill House Accommodation, Woodhill House Catering, Gordon House Catering and Halls)

- Negative impacts have been identified, these can be mitigated.
- Putting arrangements in place to ensure that Landscape services and other contractors' clear leaves and snow which will make office accommodation as accessible and safe as possible.

#### **Transportation & Roads**

## 33 Roads Maintenance Expenditure & Income, Administration & Management, Highways and Quarries

- The activity will have negative impacts which cannot be mitigated fully.
- The activity provides the financial resources to support the management and maintenance of the
  road network. The network is provided for all users. While it is recognised that a number of the
  protected characteristic groups rely more heavily on some aspects of the network, at a strategic
  level resources are predominately directed towards the maintenance of the asset. A reduction in
  the allocation of this scale will lead to negative impacts over time.

#### 34 Harbours, Flood Management and Coastal Protection

- No negative impacts have been identified.
- The activity provides the financial resources to support the management and maintenance of the necessary infrastructure. This is done in an open, transparent and sympathetic manner.

#### 35 Internal Transport and Vehicle Maintenance Services

- · No negative impacts have been identified.
- The delivery of all services by the Council is done in line with appropriate legislation and where changes are made that require the support of Fleet and Vehicle Maintenance Services these will then be reflected within future strategies and budgets as required.

- The activity will have negative impacts which cannot be mitigated fully
- The reduction in the level of service will lead to negative impacts which cannot be mitigated.

#### 37 Public Transport Unit

- · No negative impacts have been identified.
- The activity provides the financial resources to support the delivery of passenger transport services in accordance with the Council's Passenger Transport Strategy. The needs of the protected groups are taken into account when specifying, procuring and operating passenger transport services and associated infrastructure.

#### **Property**

#### 38 Estates

- Negative impacts have been identified, these can be mitigated.
- We will ensure that mechanisms are in place for the reactive maintenance of buildings.

## 39 Construction Services [Property Construction Services (Architecture; Asset Management; Building Management; Engineering Services and Quantity Surveying)]

- No negative impacts have been identified.
- The setting of a revenue budget for the provision of Property Construction Services does not in itself impact on the protected groups.

#### 40 Economic Development

  decisions are made about the budget for 2014-15 and beyond it will be necessary to look at
  these afresh. Any decision to reduce the Chief Executive budget would be likely to have some
  impact, especially as there is a clear focus on the SOA and given the priorities identified for
  Aberdeenshire.

#### 44 Business Services Directorate

- No negative impacts have been identified.
- The budget funds the Director and Personal Assistants salaries and costs and also delivery of support services mainly through staff resources and associated supplies and services e.g. ICT equipment, licence costs, office equipment and stationery.

#### 45 Finance

- No negative impacts have been identified.
- The Finance Service is an over-arching service which supports the Council to deliver its various priorities by promoting the proper administration of the Councils financial affairs. It is the individual Services decisions that will potentially impact on the protected groups rather than the Finance Services decisions.

#### 46 Revenues

- No negative impacts have been identified.
- The Revenues budget is an over-arching budget which supports how the council and its services bill and collect all sums due to the council. As the remit of the team is constrained by a legislative framework at UK and Scottish Government level, it is more appropriate to consider any negative or positive impacts as and when the revenues team develops projects that form part of a council driven improvement agenda.

#### 47 Benefits

- The Benefits budget is an over-arching budget which supports how the council deliver financial assistance to its residents. As the remit of the team is constrained by a legislative framework at UK Government level, it is more appropriate to consider any negative or positive impacts as and when the benefits team develops projects that are part of a council driven improvement agenda.

#### 48 Internal Audit

- No negative impacts have been identified.
- Internal Audit provides assurance over the governance arrangements of the Council and therefore has a neutral impact on those with protected characteristics.

#### 49 Human Resources and Organisational Development

- No negative impacts have been identified.
- Given that one of the main aims of the HR & OD service is to aid the equality of opportunity for all employees in the workplace it is not considered that allocation of the HR & OD budget will impact negatively on any protected characteristic group.

#### 50 Information and Communications Technology

- The ICT revenue budget does not negatively affect any groups with protected characteristics. The service will continue to support other services to identify and implement ICT related requirements for groups.

#### 51 Legal and Governance

- Only positive impacts have been identified since the equalities culture and the public sector duty in particular only stand to be enhanced and reinforced by the provision of a fit for purpose Legal & Governance service.

#### **Customer Communications and Improvement**

#### 52 Communications

- · No negative impacts have been identified
- The Communications budget is an over-arching budget which supports how the council and its services communicate with all of its audiences. As the remit of the team is so broad, it is more appropriate to consider any negative or positive impacts as and when the communications team develops communications plans and budgets for individual, services-led projects.

#### 53 Performance and Improvement

- No negative impacts have been identified
- The Performance & Improvement budget supports services and there are no negative impacts because the purpose of the support we deilver is to provide employees and managers with the tools and information to enhance their self assessment and awareness, performance management and related improvement activities. As well as ensuring that services adhere to their obligations and the relevant action plans to ensure compliance with The Equality Act (2010) and ensuring proportionate actions to support Gaelic Language.

#### 54 Design and Print

- No negative impacts have been identified
- The Design and Print budget is managed on a cost recovery basis which supports other services to produce information in an accessible format.

#### 55 Procurement

- · No negative impacts have been identified.
- The budget funds the salaries and costs and also delivery of procurement services mainly through staff resources and associated supplies and services.

#### 56 Miscellaneous Services

- No negative impacts have been identified.
- There is no differential impact. This budget fluctuates according to how many licences are applied for in any given year. If this budget were to be increased, decreased or stay the same, this would have no differential impact on those with a protected characteristic. It would merely reflect the number of licences applied for and thereby would be linked to the applications submitted by the public as a whole and the protected groups are no more likely to be adversely affected than those without a protected characteristic since the provision of licences to undertake certain activities are regulated within Scotland on an already non-discriminatory basis with equality and fairness of opportunity for all citizens through access to licences to allow them to undertake certain activities that it is believed to be in the public interest to regulate.
