

The subjects are located in Linton Business Park situated on the northern outskirts of the village of Gourdon, located some 28 miles south of Aberdeen via the A90 and A92. Gourdon is a small fishing village located on the Kincardine and Mearns coast with convenient access to the A90.

Description:

The site extends from approximately 0.69 Hectares (1.70 Acres) and offer the opportunity for industrial development or general storage. The area is reasonably level.


Planning:
