## Location:

The unit is located within the Dales Industrial Estate to the south of Peterhead town centre and may be approached from the A90 by way of Damhead Way leading to Damhead Road. Peterhead is located on the Buchan coast some 30 miles north of Aberdeen. The A90 allows for easy access to Aberdeen to the south and Fraserburgh to the north.

## Description:

The property comprises a single storey mid-link unit suitable for a range of business uses, light industry, general industrial, storage or distribution. To the rear of the property is a fenced compound across which there is shared vehicular access for the adjoining unit (Unit 10). Vehicular access to the unit is via a metal roller shutter door to the front. There is space for car parking on the forecourt at the front as well as within the communal car park.

Welfare facilities include a WC & WHB.

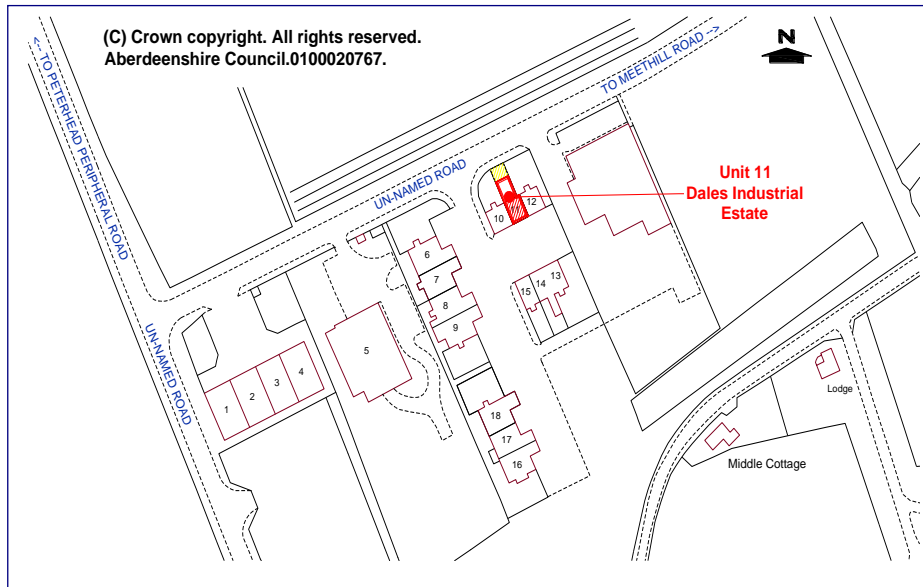

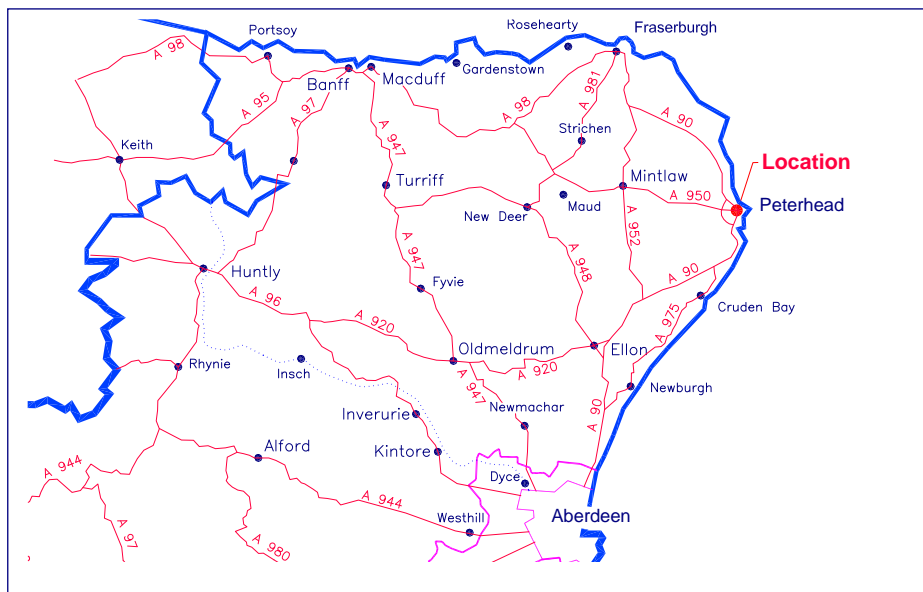
