



# ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2010 PROPOSED PLAN RESPONSE FORM

The proposed plan is Aberdeenshire Council's set view of what new land should be made available for building in the period to 2016, with a firm indication of that land which should be brought forward for the period to 2023. It also contains policies by which land use decisions will be made.

The proposed plan has been designed to be concise and map based. Much of the detail has been presented in separate "Supplementary Guidance". If we are unable to resolve objections to the proposed plan these will be forwarded to a person appointed by Scottish Ministers for examination, and they will amend the plan as they see fit. Supplementary guidance is not examined in this way and is for Aberdeenshire Council to amend and approve after consideration of representations. This form may be used to accompany a representation to the **proposed plan only**. A separate form has been produced to receive views on the supplementary guidance.

It is important that you **identify the issue** that the comment concerns. A list of potential issues is presented on the following page. It is also helpful for you to **explicitly state the modification(s) that you would wish to see** to the plan. If you wish to see multiple modifications to the plan, then please complete more than one form.

Finally you should be aware that Scottish Ministers have suggested that representations made by stakeholders should be concise (no more than 2000 words plus any limited supporting productions) and that there is no further opportunity to expand your submission later in the process.
