



Proposed Special Landscape Areas Supplementary Guidance Consultation Response Form



The Special Landscape Areas Supplementary Guidance is one of a series of Supplementary Guidance documents being prepared to support the next Aberdeenshire Local Development Plan (LDP), which is expected to be adopted in late 2016. The purpose of this Supplementary Guidance is to support Policy E2 *Landscape* of the Proposed Aberdeenshire LDP 2016.

Based on the landscape assessments and community engagement undertaken by Land Use Consultants (LUC), on behalf of Aberdeenshire Council, this Supplementary Guidance has been produced to incorporate local landscape designations into the Aberdeenshire LDP area. It identifies **ten candidate Special Landscape Areas** across Aberdeenshire's rich and diverse landscape on which would welcome your views.

This is your opportunity to tell us what should be changed in the Supplementary Guidance, and why. When writing a response to the proposed Supplementary Guidance it is important to specifically state the modification(s) that you would wish to see. This is the only remaining opportunity to comment on the Supplementary Guidance.

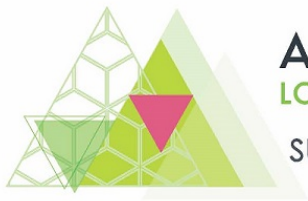
