

# NOTICE OF ELECTION

## UK Parliamentary Election

### For the Banff and Buchan Constituency, Gordon Constituency and West Aberdeenshire and Kincardine Constituency

1. An Election is to be held for a Member of Parliament to serve each of the Banff and Buchan Constituency, Gordon Constituency and West Aberdeenshire and Kincardine Constituency.
2. Nomination papers can be obtained on weekdays between **10.00am and 4.00pm** (excluding public holidays) from the offices of the Returning Officer, as follows:-

(for the BANFF AND BUCHAN Constituency)**

**Gordon House, Blackhall Road, Inverurie  
(for the GORDON Constituency)**

3. Nomination papers must be delivered to the Returning Officer at the above addresses, by prior appointment, on any weekday after the date of this notice, from **10.00 a.m. to 4.00 p.m.** (excluding bank holidays), **but no later than 4.00 p.m. on Thursday 14 November 2019.**
4. If the election is contested, the poll will take place on Thursday 12 December 2019.
5. Applications to register to vote must reach the Electoral Registration Officer by **12 midnight on Tuesday 26 November 2019.** Online applications to register can be made at [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote).

6. The £500 deposit can be paid by legal tender, electronic transfer or by means of a banker's draft from a drawer which carries on business as a banker in the United Kingdom.
7. Applications for new postal votes and amendments or cancellations of existing absent voting arrangements must reach the Electoral Registration Officer at Woodhill House, Westburn Road, Aberdeen, by **5.00 p.m. on Tuesday 26 November 2019**.
8. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Woodhill House, Westburn Road, Aberdeen, by **5.00 p.m. on Wednesday 4 December 2019**.
9. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Woodhill House, Westburn Road, Aberdeen, by **5.00 p.m. on 12 December 2019**. The physical incapacity must have occurred after 5pm on Wednesday 4 December 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday 4 December 2019.
