Location:

The property is located within Linton Business Park, Linton Road, Gourdon, a short distance east of the A92 Stonehaven to Dundee coast road. Gourdon is a coastal fishing village located approximately 27 miles south of Aberdeen and 13 miles north of Montrose.

The approximate location is shown on the Location, Town and Site plans.

Description:

The property comprises a mid terraced workshop unit with concrete block walls and floor. The roof is pitched with insulated profile sheet cladding and translucent roof lights. Vehicular access is provided by a steel roller shutter door; a separate pedestrian door provides personnel access. Internally there is a single office with carpet tile floor coverings, electric wall mounter heaters and natural light. Common car parking is available at the front of the property. The unit has a washbasin and WC facility, fluorescent strip lighting and 3 phase power.
