The unit is located within Dales Industrial Estate to the south of Peterhead town centre and maybe approached from the A90 by way of Damhead Way leading to Damhead Road. Peterhead is located on the Buchan coast some 30 miles north of Aberdeen. The A90 allows for easy access to Aberdeen to the south and Fraserburgh to the north.

Description:

The property comprises a single storey end linked unit suitable for a range of business uses, general industrial, storage and distribution. To the rear of the property is an enclosed compound with gated vehicular access. Vehicular access to the unit is via a metal roller shutter door with separate pedestrian access. There is a space for car parking of the forecourt at the front of the unit, as well as within the communal car park.

The unit benefits from having a separate WC and wash facility.
