1. Overview

This document has been generated from information entered into the Integrated Impact Assessment system.

Assessment of budget pressure - provision of additional seasonal garden waste collection points. Previous reporting to ISC with regards to provision of garden waste collection service identified communities that could benefit from a seasonal garden waste collection service based on increased number of housing and/or distance to a recycling centre or seasonal collection point. With the introduction of the 3 weekly waste collection frequency, this will push garden waste out of the residual waste bin due to the reduced capacity of the bin and therefore providing additional seasonal garden waste points in locations where there is household demand/requirement for such a service would assist in capturing that garden waste for composting/recycling therefore reducing the impact of it ending up as waste or being flytipped. It should be noted that this would be a new service and therefore when considering budgets, the priority is to ensure that budget is available to continue providing existing essential statutory services e.g. budget for agency staffing to ensure that scheduled recycling and waste collection services are able to be staffed consistently despite sickness leave / annual leave.

During screening 4 of 10 questions indicated that detailed assessments were required, the screening questions and their answers are listed in the next section. This led to 2 out of 5 detailed impact assessments being completed. The assessments required are:

- Equalities and Fairer Scotland Duty
- · Sustainability and Climate Change

In total there are 0 positive impacts as part of this activity. There are 6 negative impacts, of these negative impacts, 0 have been mitigated and 6 cannot be mitigated satisfactorily.

Internal Data	Waste Data	Garden waste tonnage has increased for 2023.	With the new collection service restricting the residual waste bin capacity, householders are utilising the existing garden waste collection services to recycle additional garden waste.

4.5. Engagement with affected groups

None as no decision has actually been taken to extend the garden waste services - this is a new service which would only be provided if and when resources allow.

4.6. Ensuring engagement with protected groups

No engagement undertaken yet. The IIA has been based on not having the funding to take this expansion of garden waste seasonal points forward however at this present moment in time these communities do not have the service so if there is no funding for this then nothing will change. If funding was to be available and this expansion was to proceed the impact would change from being a negative to a positive as this would make it easier on those protected characteristics to be able to recycle garden waste within their community and engagement would be undertaken at that time.

4.7. Evidence of engagement

As stated previously, the expansion of the seasonal garden waste services would only take place if and when resources allow and engagement would only happen should this proceed.

4.8. Overall Outcome

Only Some Negative Impacts Can Be Mitigated.

Potentially, this budget pressure could be absorbed by funds identified in the 3 weekly budget however priority for any spare budget should be used towards being able to keep existing waste and recycling collection services covered i.e. to help cover agency staffing costs as this takes priority.

There are alternative options for garden waste recycling by transporting it to the nearest HRC/ seasonal garden waste points or by home composting (discounted composting bins available from the Council).

A justification for continuing despite unmitigated negative impacts has not been entered.

4.9. Improving Relations

No decision has actually been taken to extend the garden waste services - this is a new service which would only be provided as and when resources allow.

4.10. Opportunities of Equality

Should resources be available to allow this to proceed, this would provide more communities with the opportunity to recycle garden waste within their community without the need to transport garden waste to their next nearest HRC or seasonal garden waste point.

Quality of environment	By not extending the seasonal garden waste points for up to a further 5 communities, there is potential that garden waste could continue to end up in the residual waste bin therefore not reducing waste arisings or increasing recycling tonnages. With the reduction on residual waste bin capacity, this could mean householders do not have the capacity within their bin for the garden waste and therefore this may end up getting flytipped which would impact on the quality of the environment. 	Justification	Householders still have the option to take garden waste to their nearest HRC or seasonal garden waste collection point or alternatively home compost - discounted composters are available from the Council. Potentially, this budget pressure could be absorbed by funds identified in the 3 weekly budget however priority for any spare budget should be used towards being able to keep existing waste and recycling collection services covered i.e. to help cover agency staffing costs as this takes priority.

Sampling undertaken during June/July found that during peak growing season garden waste accounted for 18.7% of the residual waste bin.	Householders will continue to use their residual waste bins for garden waste if there are no facilities to recycle their garden waste located conveniently nearby.
