Location:

The property is located within Linton Business Park, Linton Road, Gourdon, a short distance east of the A92 Stonehaven to Dundee coast road. Gourdon is a coastal fishing village located approximately 27 miles south of Aberdeen and 13 miles north of Montrose. The approximate location is shown on the Location, Town and Site plans.

Description:

The property comprises two adjoining, interconnected workshop units. These have concrete block walls and floor. The roof is pitched with insulated profile sheet cladding and translucent roof lights. Vehicular access is provided by steel roller shutter doors; a separate pedestrian door provides personnel access. Internally there is a single office with carpet tile floor coverings, electric wall mounter heaters and natural light in each unit. Common car parking is available at the front of the property. The units have a washbasin and WC facilities, fluorescent strip lighting and 3 phase power. The units are available either together or separately.

Services:

Council Tax Banding/Rating Information:

The Valuation Roll shows a rateable value for the properties of £5,700 per unit with effect from 1st April 2023.

The Uniform Business Rate (UBR) for the year 2025/2026 is 49.8p in the pound. A tenant may qualify for 100% rates relief under the Small Business Bonus Scheme.

Planning:

The industrial unit is being offered for lease on the basis of uses falling within Class 4, 5 & 6 of the Use Classes (Scotland) Order 1997, however interested parties should seek advice or make their own enquiries as to whether their intended use would fall within the definition of this class.

Rent:

Rent £9,000 per annum per unit or £18,000 as a whole.

VAT:

All prices, rents and premiums quoted are exclusive of VAT. VAT will be payable on the rent.

Lease Terms:

Aberdeenshire Council is seeking to lease the property on a six year internal repairing and insuring basis, incorporating a rent review after the third year. There will be options for the tenant to terminate at the

end of the 1st, 2nd and 3rd years, subject to a penalty payment of 15% of the annual rent. No service charge.

Legal Costs:

In the usual manner, the ingoing tenant will pay the Landlord's reasonably incurred legal expenses, as well as any applicable LBTT and registrations dues.






Location Plan:
