GUIDANCE NOTE AND CRITERIA

PLEASE READ CAREFULLY BEFORE COMPLETING YOUR APPLICATION

Projects must address one of the Coastal Communities priorities;

- 1. Support the development of active travel routes along, to and from the coastline
- 2. Developing the coastal economy, workforce and sustainable tourism
- 3. Create or enhance community, leisure, and recreational facilities
- 4. Safeguard, restore, or enhance the coastal environment

Before you start check this is the correct guidance for your project.

- Applications of up to £1000 read the criteria and complete the Coastal Communities Buchan Small Grant application form
- Applications of between £1000 and £5000 read the Standard Grant Guidance and complete the Standard Coastal Communities Buchan application Form
- Applications of between £5001 and £9999. Note that such application will be considered in exceptional cases and projects must be featured in a community led plan. Read the Standard Grant Guidance and complete the Standard Coastal Communities Buchan application Form
- Applications for £10,000 or more must first complete an Expression of Interest. Read the guidance and submit an Expression of Interest for approval. In most cases. community led projects on this scale

Applications for up to £1000 can be made using this form.

Applications will be assessed on a first come first served basis as the Buchan Area Team receive them.
