We refer to our appointment by the Scottish Ministers to conduct the examination of the Aberdeenshire Local Development Plan. We have completed the examination, and now submit our report, enclosing one bound copy and one loose leaf copy.

Our report has taken account of the Strategic Environmental Assessment and the Habitats Regulations Assessment of the Plan, and the representations received in response to both assessments.

Before carrying out the examination into the issues raised in representations, we carried out an assessment of the council's conformity with its participation statement under Section 19(4) of the Town and Country Planning (Scotland) Act 1997 (as amended), which is detailed in Issue 1 of this report. Overall we concluded that the council met the intentions of the participation statement, insofar as it was reasonable to do so, and ensured a high level of engagement in line with the expectations of Scottish Ministers.

In our examination we considered all 152 issues arising from unresolved representations which were identified by the council. In each case we have taken account of the council's summary of the representations, together with the original representations, and the council's responses thereto. We have set out our conclusions and recommendations in relation to each issue in our report.

During the course of the examination we carried out an extensive number of unaccompanied site inspections. On certain issues we requested further information in accordance with Regulation 22(1) of the Town and Country Planning (Development Planning) (Scotland) Regulations 2008.

As part of the examination we sought further information from neighbours in relation to sites under consideration at Alford, Daviot, Insch, Inverurie, Kennethmont, Luthermuir, Montgarrie, Newburgh, Oldmeldrum, Portsoy, Roadside of Kinneff, Tarland, and Torphins. The proposers of the sites and the council were given the opportunity to respond to the comments received from neighbours.

Subject to the limited exceptions as set out in section 19 of the Town and Country Planning (Scotland) Act 1997 and in the Town and Country Planning (Grounds for Declining to Follow Recommendations) (Scotland) Regulations 2009, the council is now required to make the modifications to the proposed local development plan as set out in our recommendations. Any other minor modifications made by the council should not be of the type defined in regulation 15(1) of the Town and Country Planning (Development Planning) (Scotland) Regulations 2008.

The council should also make any consequential modifications to the text or proposals maps which arise from these modifications. In addition the council will wish to consider whether any associated documents, including the environmental report and supplementary guidance, require amendment as a result of the proposed modifications.

A letter will be issued to all those who submitted representations to inform them that the examination has been completed and that the report has been submitted to the council. It will advise them that the report is now available to view at our web site at:
