1(a) the degree to which the PPS sets a framework for projects and other activities, either with regard to the location, nature, size and operating conditions or by allocating resources	Yes	The strategy will influence grants for woodland management and creation through the Scottish Rural Development Programme and potentially other grant funding process of relevance. It will also have influence on development management. It could influence a wide range of project related to forests and woodland from community ownership, business development to environmental protection and climate change mitigation.
1(b) the degree to which the PPS influences other PPS including those in a hierarchy	Yes	The strategy could influence strategic and local development plans, river basing management planning, forest management plans, the Scottish Rural Development Programme, flood risk management plan, climate change action plans, the North East Scotland Biodiversity Action Plan and community planning.

1(c) the relevance of the PPS for the integration of environmental considerations in particular with a view to promoting sustainable development	Yes	The strategy will be strongly focussed on effective integration of new woodland into exiting land use (including new built development) so as to deliver multiple benefits. It will promote the management of existing woodland to derive social, environmental and economic benefits.
1(d) environmental problems relevant to the PPS	Yes	There are a number of conflicts between potential woodland expansion and other land uses such as sport shooting or agriculture. Climate change is likely to have significant effects on woodlands as well as other land uses. A number of the habitats and species associated with woodlands are declining. Aberdeenshire hosts a number of nationally important populations of key woodland species and habitats. Deer browsing in relation to woodland regeneration is a significant issue. There are Scottish Government targets for woodland expansion but planting rates need to increase to meet these. Woodland has the potential to benefit flood prevention and water quality. There is the need to take account of the historic environment in planning woodland creation and management.
1(e) the relevance of the PPS for the implementation of Community legislation on the environment (for example, PPS linked to waste management or water protection)	Yes	This PPS is likely to be relevant to the implementation of a number of EU Directives, including the Water Framework Directive, Climate Change Directive, Habitats and Birds Directive, Biodiversity Action Plan and the Common Agricultural Policy. It is also likely to have relevance to Community Empowerment.
2 (a) the probability, duration, frequency and reversibility of the effects	Yes	While it is not envisaged that this PPS is likely to have any significant negative effects on the environment, long term effects environment are likely due to the long term nature of forestry and woodland creation. It should be noted that the strategy will not directly instigate

		woodland planting and forestry activity but would be one element out of a number that will influence decision making and practice.
2 (b) the cumulative nature of the effects	Yes	There is a high level of interaction between different types of land uses, so any positive or negative effects arising from this PPS are likely to have significant secondary, indirect or induced environmental effects.
2 (c) transboundary nature of the effects (i.e. environmental effects on other EU Member States)	Yes	Land use change, disturbance of carbon rich soils, use of forestry resources and how man engages with land are likely to affect climate change, which pervades national boundaries. There is the potential to influence national and internationally important species and habitats.
2 (d) the risks to human health or the environment (for example, due to accidents)	No	No significant risks to the environment or human health are anticipated. The strategy will aim to ensure that environmental risks from woodland creation and management are minimised. It will also promote activities that will benefit human health by providing recreational access and improvements to environmental quality.
2 (e) the magnitude and spatial extent of the effects (geographical area and size of the population likely to be affected)	Yes	The strategy will have an influence across Aberdeenshire Local Authority area out-with Cairngorms National Park.
2 (f) the value and vulnerability of the area likely to be affected due to- (i) special natural characteristics or cultural heritage; (ii) exceeded environmental quality standards or limit	Yes	There are a range of important local, national and international designations in within the area covered by the strategy – SPA's, SAC's, RAMSAR sites, SSSI, National Scenic Areas, Scheduled Ancient Monuments and Designed Landscapes etc. all of which could be influenced by the PPS. The strategy will aim to take account of

values; or (iii) intensive land-use.		<p>area of valuable and intensive land uses and will protect these, where relevant.</p> <p>The strategy will strongly consider historic and cultural heritage implications of woodland management and planting.</p>
2 (g) the effects on areas or landscapes which have a recognised national, Community or international protection status	Yes	<p>There is the potential for woodland management and creation to influence landscapes. How to integrate woodland creation and management with designated and non-designated landscapes is likely to be an element of the strategy.</p>

A summary of our considerations of the significant environmental effects of Aberdeenshire Passenger Transport Strategy is given below.

TABLE 2 – SUMMARY OF ENVIRONMENTAL EFFECTS

The PPS has a range of potential environment effects based on its identification of priorities for woodland management and creation in the region, its identification of preferred areas for new woodland planting and its potential to influence other PPS as well as grant processes.

It is envisaged that the strategy will have significant positive environmental effects. In carrying out Strategic Environmental assessment we will aim to maximise these positive effects. It must be borne in mind that the strategy will not directly instigate on-the-ground effects but will set a high level direction and would only be one element in a land use decision.

It will be a core aim to the strategy to have no significant negative environmental effects. However, there can be trade-offs in relation to woodland management, or the creation of productive woodland, and environmental objectives, this needs exploration in developing the strategy.

Trans-boundary and cumulative effects from the PPS cannot be overruled.

For the reasons outlined it is considered that the PPS is likely to have significant effects. Further steps will be taken to undertake strategic environmental assessment
