
NOTES

- 1. This consent may be revoked at any time by the Head of Service Roads & Infrastructure.
 - 2. The current charge for the keep clear marking is £391.68 incl. VAT.
- 3. This charge does not apply to disabled badge holders. Applications relating to an address which is the permanent residence of a disabled person should be made using the "Application for Parking Facility for Disabled Person" form.
- 4. The applicant will be responsible for all future maintenance costs including replacing after any roadworks. All maintenance works must be carried out by a contractor approved by Aberdeenshire Council for road marking works.
- 5. The marking has no legal standing and is not enforceable. The Chief Constable can only take action if an actual obstruction takes place, i.e. someone is actually requiring in and out of the access at that time. Parking on the marking is not an offence on its own.

An invoice will be issued for the amount due above.
