

WESTHILL PROPOSED REMOVAL OF PROHIBITION OF RIGHT TURNS

Aberdeenshire Council proposes to make "The Aberdeenshire Council (B9119 and Exploration Way, Westhill) (Removal of Prohibition of Right Turn) Order 2025" under the Road Traffic Regulation Act, 1984.

The effect of the order will be to remove the prohibition of right turns at the following locations in Westhill:

B9119 – from B9119 to Exploration Way Exploration Way – from Exploration Way to B9119



STATEMENT OF REASONS

PROPOSED REMOVAL OF PROHIBITION OF RIGHT TURNS - WESTHILL

Aberdeenshire Council are proposing to remove the prohibition of right turns at the junction between B9119 and Exploration Way in Westhill at the new Arnhall Business Park. Since the approval of the no right turns, the junction has been redesigned to improve traffic flow and address issues raised with the existing junction. As a result, the prohibition of right turns are no longer required.
