

PEDEX CROSSING

Aberdeenshire Council proposes to introduce a PEDEX crossing in Peterhead under Chapter 27, Section 23 of the Road Traffic Regulation Act, 1984.

PEDEX crossing location - A982, Peterhead, from a point 105 metres east of the extended east kerb line of the U190b Balmoor Terrace to a point 150 metres east of the extended east kerb line of the U190b Balmoor Terrace.

STATEMENT OF REASONS
PETERHEAD - PROPOSED PEDEX CROSSING

Aberdeenshire Council is satisfied that the implementation of the proposed PEDEX crossing will provide a safer means of crossing the A982 Peterhead. The crossing has been assessed in line with the Pedestrian Crossing Assessment Policy where it met the criteria for the introduction of a PEDEX crossing.

- Footway reconstruction - See detail on drawing 761060-D-DG-003
- High friction surfacing - Cold applied epoxy resin with grey calcined bauxite
- Red blister tactile slabs
- Concrete hardstanding (ST2 Concrete 100mm)
- Traffic Signal Infrastructure - See Notes
- SSE Supply Cable - Contractor to excavate joint pit, cable trench, install roped duct and reinstate. See SSE drawing for details

- Existing BN kerbs
- Double dropper - Type K20/21 A&B - See detail b89
- Half battered - Type K2 - See detail b70
- Flat top edging - Type K13 - See detail b71
- Round top edging - Type K12 - See detail b71
- Bus Stop Kerb - See detail b88
- Quadrant Kerb


Notes: Road Markings:

- Road markings to be formed in Cold Plastic Methyl Methacrylate (MMA)
- Existing double yellow markings burnt off where required and terminated at new position as shown.
- Existing road markings shown on the drawing are all to be **100** refreshed.

Notes: Traffic Signal Infrastructure

- Traffic Signal layout and position of apparatus shown on drawing: 3090001563-YU-00-XX-DR-Y-0001
- Traffic Signals and cabling will be installed by Yunex.
- Civil Engineering items as identified on Yunex design drawing are to be supplied and installed by Contractor.
- Contractor is to supply and install roped ducts, duct chambers, retention sockets, electrical mini pillar and install base for controller cabinet (base supplied by Yunex)
- Contractor to co-ordinate installation of Traffic Signals with Yunex
- Contractor to co-ordinate with SSE and install electrical supply to mini pillar. SSE connection for new supply will be arranged for and paid for by Client.




